Re: 1978 Latter-Day Saints Attorneys Convention

Dear King County LDS Attorneys:

Steve Pond of Longview has agreed to do some initial exploratory work regarding the possibility of a Latter-Day Saints Attorneys Convention in the spring.

Just to get something in front of everyone, Steve proposes we meet in Cannon Beach, Oregon at the Tolovana Inn on the weekend of March 17, 18 and 19. (March 17 is apparently a holiday for the Longview School District.)

We are in the roughest planning stages at this juncture, and any suggestions you have would be appreciated. We are giving some thought to the possibility of some speakers or discussion group leaders (either from the "outside" or from among us) on issues of importance and interest to the LDS attorney, as well as perhaps a special fireside. We could also probably plan on activities which could include the entire family.

The Tolovana Inn has conference rooms which can be used at no cost to parties registering at the Inn. Rates run from \$18.00 to \$32.50 per night, depending on ocean view, while suites for six run from \$45.00 to \$65.00 per night. Points of interest in the area besides the ocean, include nearby Fort Clatsop (a replica of the Lewis & Clark Fort), some military


